FUNCTIONAL CAPACITY ASSESSMENT (FCA)

A comprehensive report that assesses your abilities and needs across 35 essential life tasks including communication, mobility, self-care, social participation, learning and working. For people needing less than six hours of daily support, who are not planning on living in a different home in the next few years. Six to eight hours of funding needed.



HOME AND LIVING SUPPORT ASSESSMENT (HLS)

This report assesses your current housing suitability and support needs. For people who need more than six hours of daily support, and whose quality of life would be greatly improved by moving to more suitable accommodation or accessing additional support. Eight to ten hours of funding needed.



SPECIALISED DISABILITY ACCOMMODATION (SDA)

Addressing the unique requirements of Specialised Disability Housing (SDA) funding applications, this report determines your eligibility and preferences for specialised disability housing solutions that are currently not available in the market. The report also includes a timetable of supports you will need. Twelve hours of funding needed.
